Do I need a permit to import radio communications equipment?

Import permits are required for the importation of radio communications equipment pursuant to Republic Act No. 3846, as amended by Republic Act No. 584. Permits to import are required for the following radio communications equipment (see also Annex Q): ANNEX Q List of Radio Communication Equipment National Telecommunications Commission.

Why is the importation of radio communications equipment regulated?

The importation of radio communications equipment is regulated as required by law and (a) to ensure public safety and security; and (b) to adhere to international standards. Not applicable. The system applies to products originating from which country?

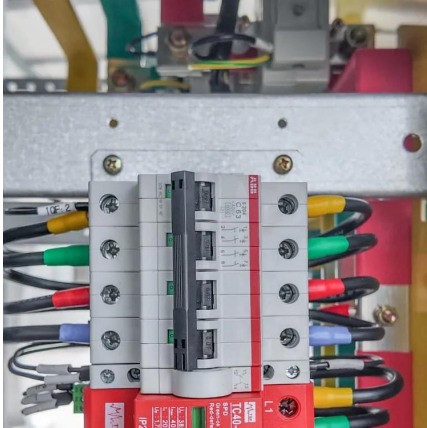

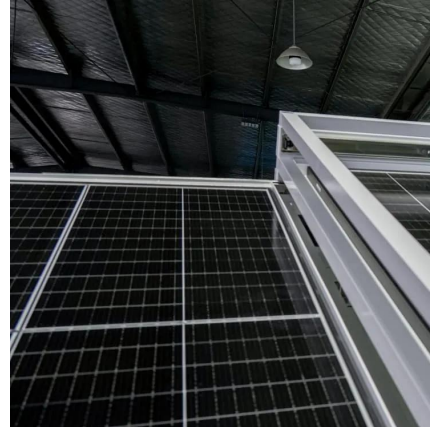
