


# **Generator removed from container**

How dangerous is a generator removal process?

Furthermore, there's always the threat of environmental damage. Fuel leakage during the generator removal process can pose extreme danger. Similarly, exposed wiring and bad connections can compromise the integrity of the main electrical connections to the facility providing power to the generator.

How long does it take to remove a generator?

A generator may also be aware this must be done within three (3) days. The previous SAA regulations at 40 CFR 262.34 (c) (2) vaguely indicated this removal be accomplished, "within three days". Under the Generator Improvements Rule, the USEPA amended the regulations to replace the term "three days" with "three consecutive calendar days".

When should a generator remove hazardous waste from a satellite accumulation area?

Generators who accumulate hazardous waste in a satellite accumulation area (SAA) are likely familiar with the requirement to remove waste from the SAA to the central accumulation area (CAA) when the threshold volume is reached. A generator may also be aware this must be done within three (3) days.




