(MTerra Solar), has closed a record-breaking ₱150 billion syndicated loan with six of the country's largest banks to finance what will be the world's largest integrated solar and battery energy storage system.

(USD 1.0 = EUR 0.918) UK investment firm Actis has finalised its investment in Terra Solar Philippines Inc, thus taking an equity stake in a GW-scale solar and energy storage project in a deal worth USD 600 million (EUR 550.5m).

How much energy will mterra solar supply to Meralco?

As of end-March 2025, the project has reached 35% overall progress. Once completed, MTerra Solar will supply 850 MW of mid-merit renewable energy to Meralco under a Power Supply Agreement.


