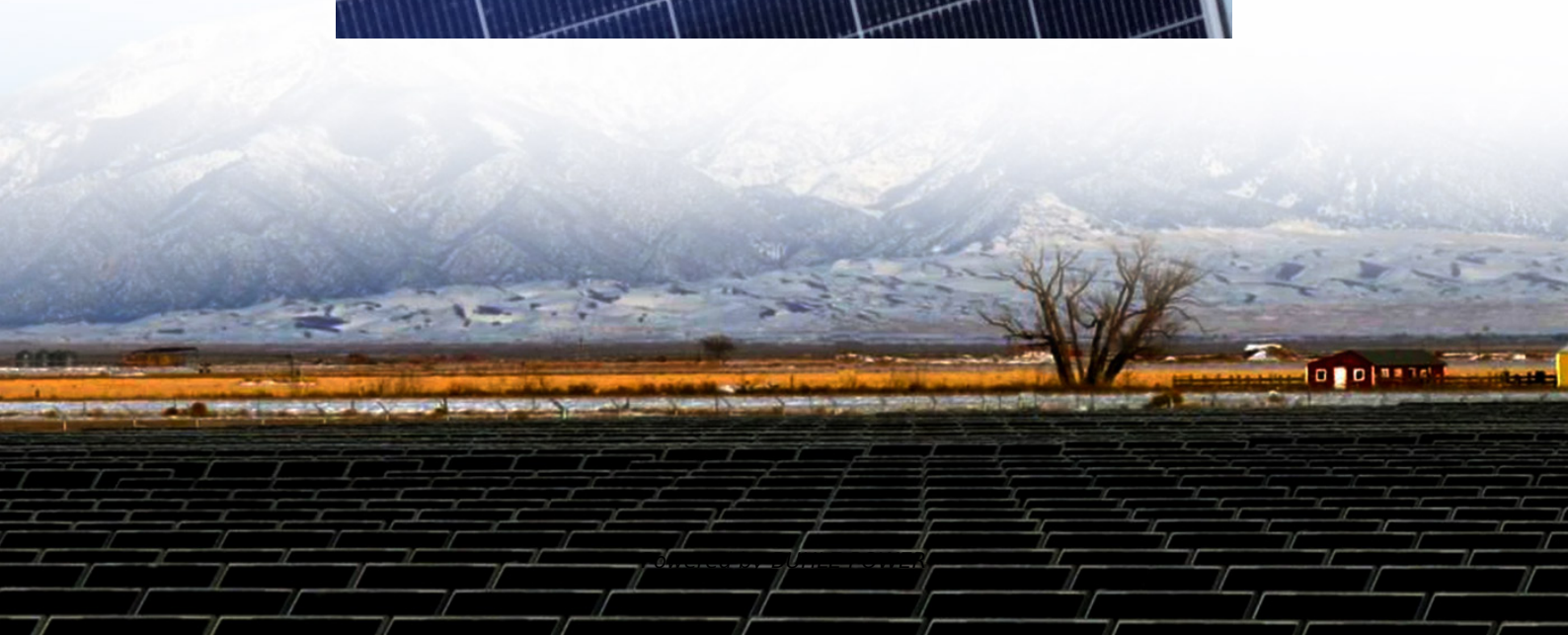


# **Solar inverter field quota**





## Overview

Are solar energy import duties a quota?

With a flurry of recent activity, the U.S. government is administering or considering import duties and quotas on imports of solar energy equipment in three areas: The solar module tariff-rate quota under the “Section 201” law. Duties on solar modules, industrial batteries and many other items under the “Section 301” law.

What is a 5 GW tariff quota?

By the end of July, there was a 5 GW tariff rate quota (TRQ) for cells. On August 12, the U.S. raised the annual TRQ for cells from 5 GW to 12.5 GW, which is applied to cells imported after August 1, 2024, while imports exceeding the old 5 GW limit before August 1 are subject to the Section 201 tariffs.

Are solar panels subject to a tariff?

Imports above quota limits are subject to a 9.6% import tariff. Decreasing quantitative limits are set from 2024 to 2027. From 2028 onwards, solar panels imports are expected to be subject to a 9.6% import tariff.

What does the Section 201 tariff rate quota mean for PV?

The increase in the Section 201 tariff rate quota to 12.5 GW represents a critical shift for the U.S. PV market. While this change temporarily eases supply constraints, it also highlights the need for strategic planning and market adaptability for companies aiming to thrive in this complex regulatory environment.

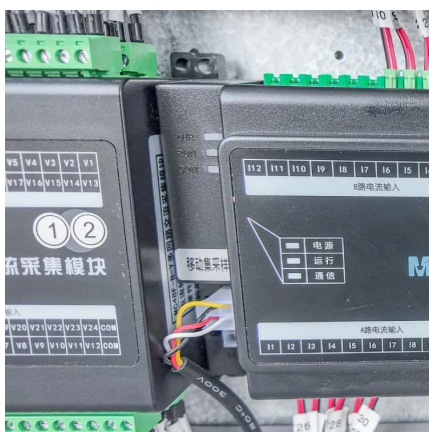

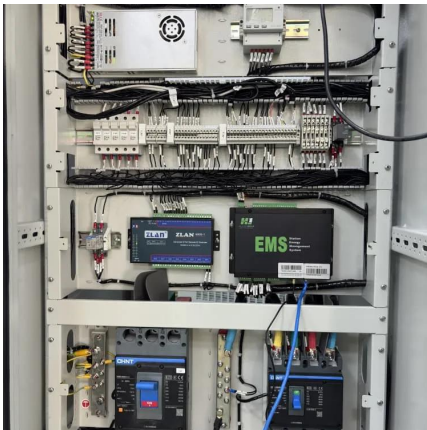
