

Overview

What is a full container load (FCL)?

Most freight shipments use containers, or pallets, crates, and boxes that fit into containers or airplane hold. There are seven incoterms dedicated to this type of cargo. A full container load (FCL) is where the shipment is to be the only one in a container.

Can FOB be used for containerized freight?

Although the ICC did not intend this incoterm for containerized freight, it is ideal and very popular for full container loads (FCL). However, it should not be used for ocean less than a container load (LCL) or air freight. FOB is not suitable for LCL or air freight, because there is a middle step for load consolidation.

What is a full container load?

A full container load (FCL) is where the shipment is to be the only one in a container. Smaller ocean freight shipments, that will be consolidated with other shipments in a container, are called less than a container load (LCL). Ocean containers are never used in air freight (although they would fit into an Anato 225). 6. What is Terminal.

What types of containers are available for lease?
