

What are the energy storage policies for Polish power plants





Overview

Poland has finalized a comprehensive subsidy program aimed at accelerating the deployment of battery energy storage systems (BESS), with a total budget of PLN 4 billion (approximately €1 billion). What is Poland's energy storage subsidy?

What are the new energy storage rules in Poland?

Poland's new rules state that energy storage facilities over 10MW require licensing to ensure they can provide services to Poland's National Power System. Facilities 10MW or smaller do not need licensing but do need to register with the transmission system operator or distribution system operator for their area.

How can energy storage support Poland's electricity system?

By addressing challenges such as peak load balancing and frequency regulation, energy storage enhances the resilience and flexibility of Poland's electricity system. The storage support program is expected to begin accepting applications in the second quarter of 2025. Full details and deadlines will be published by the NFOŚiGW.

Is energy storage a good investment in Poland?

In Poland, interest in energy storage investment has been evident for some time. Last year's main auction of the power market, with capacity delivery for 2029, further bumped up the capacity of storage projects.
